- 2. The TORs of the Grievance Redressal Committee (GRC) shall be the following:-
 - (i) The GRC shall perform its function as per the provisions of PPRA Ordinance and Rules framed thereunder;
 - (ii) The committee will have the mandate to make a full probe into the contents of complaint with powers to summon/requisition any documents and persons which could be of assistance to the committee;
 - (iii) Any individual from the Procurement Wing shall not be the part of the GRC;
 - (iv) Any other Notification (s)/Office Order (s) issued regarding constitution of the GRC previously by MoWR shall stand cancelled;
 - (v) The GRC shall be headed by Joint Secretary (Admin). The Committee shall be comprising of odd numbers of members including the Chairman;
 - (vi) The GRC shall have full powers and authorization. It shall be so independent enough to strike down a decision of procuring agency, including the decision to award a procurement contract to a particular bidder without any fear of reprisals by the senior management of the procuring agency whose decision is subjected to challenge before GRC on the complaint in writing launched by the aggrieved party; and
 - (vii) Any individual from the User Wing of MoWR/PPDU, whose procurement has been intended to be made by the Management, shall not be the part of this GRC.
